All air conditioning units must be inspected and approved for coverage by an authorized Smith's Heating & Cooling LLC Service Technician. The plan becomes effective upon inspection, and if necessary, repair of any pre-existing conditions (at customer's expense). **Each service plan applies to one unit.** Additional units may be covered for \$415 each. Any special or obsolete equipment that is no longer being manufactured may only be covered for maintaining purposes only. An emergency is defined as a no-a/c condition, or any threatening harm to people or property.

We shall make every attempt to provide you with prompt, courteous service, however, we shall not be responsible for any loss or damage caused directly or indirectly by such service, nor shall we be held responsible for any delay or inability to perform service caused by or resulting from a strike, lockouts, fire, accident, war, riot, lack of material, weather, or any other cause beyond our control. We assume no responsibility for a/c failure damage when a house or building is unoccupied or equipment damaged by power surges or portable home generators. Nor shall we assume responsibility for service performed by anyone other than a representative of Smith's Heating & Cooling LLC.
